RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AGREEMENT WITH THE CONNECTICUT OFFICE OF POLICY AND MANAGEMENT FOR ASSISTANCE PROVIDED THROUGH THE NEIGHBORHOOD YOUTH CENTER GRANT
