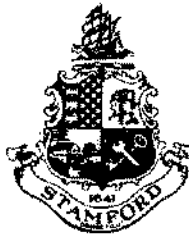

**RESOLUTION AUTHORIZING THE MAYOR TO FILE APPLICATION AND TO
ENTER INTO AGREEMENT WITH THE U.S. DEPARTMENT OF JUSTICE
FOR ASSISTANCE PROVIDED THROUGH THE LOCAL LAW ENFORCEMENT
BLOCK GRANT**
