Re: Resolution Authorizing the Mayor to Enter Into the First Supplemental Agreement Between the State of Connecticut and the City of Stamford for the Construction, Inspection and Maintenance Required in Conjunction with the Replacement of Studio Road and Buckingham Drive Bridges Utilizing Federal Funds and the State's Local Bridge Program

Dear Mr. Martin:

Enclosed please find a resolution authorizing me, as Mayor of the City of Stamford, to enter into the first supplemental funding agreements with the State of Connecticut for replacement of two local bridges: Studio Road and Buckingham Drive Bridge.

Both of these bridges qualify for federal and state assistance provided through the State Department of Transportation Local Bridge Program. Under this program 80% of the costs are provided by the federal government and 20% by the state government. The costs provided for under the bridge program relate specifically to replacement structure construction, inspection and the maintenance required. Estimates for the construction were made a year ago and were merely estimates. The project was put out for competitive bid. The First Supplemental Agreements have been put forward because the bid accepted was in an amount higher than anticipated. The bid was \$287,279 higher than anticipated on Studio Road Bridge and \$350,739 more than anticipated on Buckingham Drive Bridge. As a result, the City is being provided additional funds to implement the project. As the grant-implementing municipality, the City must agree to maintain the new bridge structure as well as operate related traffic controls.

Please review this resolution and consider it at your next full board meeting. The additional appropriation of capital funds should also be addressed at that meeting.
