RESOLUTION NO. 3202 AUTHORIZING MAYOR MALLOY TO EXECUTE APPLICATION AND AGREEMENT WITH STATE D.O.T. REGARDING WEST MAIN STREET PROJECT AND COMMITTING FUNDS TO LOCAL SHARE OF PROJECT

WHEREAS, the United States Secretary of Transportation, through the Federal Highway Administration (FHWA), is authorized to make funds available for programs deemed high priority projects as enacted through the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users (SAFETEA-LU); and,

WHEREAS, the construction of the West Main Street walking bridge and connecting trail has been identified as such a high priority project; and,

WHEREAS, the City, as applicant for the funds, will be obligated to enter into an Agreement with the State Department of Transportation providing for financial assistance and imposing certain obligations upon the applicant, including a requirement that it provide the local share of the project costs as well as a maintenance commitment; and,

WHEREAS, the reimbursement to be made to the City under such Agreement shall be paid by the State of Connecticut Department of Transportation from FHWA funds made available under SAFETEA-LU, in an amount not to exceed \$1,500,000;

NOW, THEREFORE, BE IT RESOLVED BY THE 27TH BOARD OF REPRESENTATIVES OF THE CITY OF STAMFORD:

1. That Mayor Dannel P. Malloy is authorized to execute and file an application and agreement with the Connecticut Department of Transportation for aid in financing the planning and/or construction of the West Main Street walking bridge and connecting trail project, and to take all other measures reasonably related thereto.
2. That the City of Stamford shall fund its local share of the project in the amount of \$375,000.
3. That the City shall pay and shall be solely responsible for any costs for planning and/or construction that exceed the estimated total project cost of \$1,875,000.

4. That the City of Stamford commits to maintaining the West Main Street bridge and connecting trail and any and all improvements thereto.
