WHEREAS, pursuant to such Resolution and in accordance with Sec 214-41 of the Stamford Code the Mayor has caused a report to be made on the contemplated discontinuance of Rockland Court and Rockland Place as described therein (the "Mayor's Report"); and

WHEREAS, the Director of Administration, following hearings as prescribed by Sec. 214-42 of the Stamford Code, has pursuant to Sec. 214-43 of the Stamford Code prepared his Final Report dated June 30, 2006 on the probable cost of the discontinuance Rockland Court and Rockland Place and the damages and benefits which should be assessed in favor of or against each property (the "Final Report");

NOW THEREFORE, BE IT RESOLVED BY THE 27<sup>TH</sup> BOARD OF REPRESENTATIVES OF THE CITY OF STAMFORD THAT:

The Final Report is hereby accepted without modification; and


The Board of Representatives directs the proposed discontinuance of Rockland Court and Rockland Place be carried out in accordance with the Mayor's Report and the Final Report.
