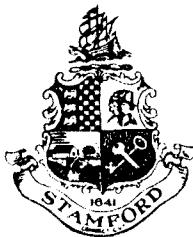

RE: Resolution Regarding the 2003/04 Tuberculosis and Sexually Transmitted Disease Treatment and Control Program.

Dear Board Members:

Attached is a resolution authorizing an agreement with the State for the Sexually Transmitted Disease (STD) Control and the Tuberculosis Treatment and Prevention Services Programs.

The STD funds are used to operate a clinic for treatment and control of these infectious diseases. In FY 2003/04 the award is expected to be \$30,441. The TB program provides care for people with tuberculosis, and helps prevent further spread of the disease. The grant award for the 2003/04 fiscal year is estimated to be \$64,375.
