Re: Resolution Authorizing the Mayor to Enter Into Agreements with the State of Connecticut for Funding Assistance Regarding Operation of the Stamford Day Care Program

Dear Mr. Martin:

Enclosed please find a copy of a proposed resolution authorizing me, as Mayor, to execute a contract so that the City can receive funding to assist the Childcare Learning Centers, Inc. in the operation of the Stamford Day Care Program. During the proposed program year, the City is eligible to receive up to \$1,645,587.00 to support program costs. This program provides affordable day care to up to 227 preschool children and 49 infants and toddlers whose parent(s) meet income criteria and work criteria established by the State of Connecticut.


This program provides a full day of day care including education, health, counseling, and nutritional programs to all participants and their families. This State funded program will operate from ten centers in the City.

The City uses the grant funds to pay salaries of staff including FICA. The Childcare Learning Centers, Inc. provides food with some assistance from the Child Nutrition Program and it provides rent and operational costs for the various centers located throughout Stamford with funds received as parental fees collected in accordance with State fee scales.

Please consider this resolution at your next full Board meeting.
