RESOLUTION NO. 3413 VALIDATING THE BUDGET ACTION TAKEN AFTER THE SPECIFIED DATE AS REQUESTED BY THE BOARD OF EDUCATION

WHEREAS, Charter Section C8-30-4, Preliminary Budget of the Board of Education, states that "The Board of Education shall provide the Mayor, by March first, on a year-by-year basis, the total dollars requested in its budget for each of the next three fiscal years and estimates of non-tax revenues for each such period;" and

WHEREAS, Section C8-30-14 the Charter provides for the validation of any action taken in connection with the Board of Education budget which takes place after the last date specified for such action by a two-thirds vote of the Board of Representatives; and

WHEREAS, due to extraordinary weather conditions during the winter of 2011, several public meetings scheduled by the Board of Education relating to its budget for Fiscal Year 2011-12 were required to be cancelled and rescheduled, resulting in the delay of the preparation of the Board of Education's budget for Fiscal Year 2011-12; and

WHEREAS, as a result of such delays, the Board of Education may not be able to provide the Mayor with the total dollars requested in its budget for each of the next three fiscal years and estimates of non-tax revenues for each such period until March 7, 2011, and

WHEREAS, it has been determined that it is in the best interest of the City of Stamford to validate the submission of the Board of Education of the total dollars requested in its budget for each of the next three fiscal years and estimates of non-tax revenues for each such period to the Mayor after March 1, 2011.

NOW THEREFORE BE IT RESOLVED BY THE 28TH BOARD OF REPRESENTATIVES THAT:


The provision by the Board of Education to the Mayor of the total dollars requested in its budget for each of the next three fiscal years and estimates of non-tax revenues for each such period on March 7, 2011 is hereby validated.
