WHEREAS, at its meeting held October 3, 2006, the Board of Representatives of the City of Stamford adopted Resolution No. 3110 entitled "Notice of Intent to Discontinue Ludlow Place Stamford, Connecticut"; and

WHEREAS, pursuant to such Resolution and in accordance with Sec 214-41 of the Stamford Code the Mayor has caused a report to be made on the contemplated discontinuance of Ludlow Place as described therein (the "Mayor's Report"); and

WHEREAS, the Director of Administration, following hearings as prescribed by Sec. 214-42 of the Stamford Code, has pursuant to Sec. 214-43 of the Stamford Code prepared her Final Report dated March 21, 2007 on the probable cost of the discontinuance of Ludlow Place and the damages and benefits which should be assessed in favor of or against each property (the "Final Report");

NOW THEREFORE, BE IT RESOLVED BY THE 27TH BOARD OF REPRESENTATIVES OF THE CITY OF STAMFORD THAT:

The Final Report is hereby accepted without modification; and


The Board of Representatives directs the proposed discontinuance of Ludlow Place be carried out in accordance with the Mayor's Report and the Final Report.
