RESOLUTION NO. 3284 NOTICE OF INTENT TO DISCONTINUE COLAHAN STREET, STAMFORD, CONNECTICUT

WHEREAS, the Board of Representatives of the City of Stamford is contemplating the discontinuance of Colahan Street, Stamford, Connecticut, more specifically depicted in the attached plan entitled "General Location Survey Depicting the Discontinuance of Colahan Street, Stamford, Connecticut" prepared by Redniss and Mead, Inc. and dated March 8,2009 (Exhibit A)" which is owned by the City of Stamford; and

WHEREAS, Colahan Street, which the Board of Representatives is contemplating discontinuing, begins at land owned by the City of Stamford at the intersection of Colahan Street and Stillwater Avenue and continues northerly for approximately 105 lineal feet to property owned by the Housing Authority of Stamford. The road width of Colahan Street is 30.62 feet at the Southerly portion of the street and 30.54 feet at the Northerly portion of the street as depicted on Exhibit A. The total area of Colahan Street is 3,168 square feet as depicted on Exhibit a.

NOW THEREFORE, BE IT RESOLVED BY THE 27TH BOARD OF REPRESENTATIVES OF THE CITY OF STAMFORD THAT:'

The public health, safety and welfare, convenience and necessity may require the discontinuance of Colahan Street as shown on Exhibit A; and

Pursuant to the provisions of Section C8-60-3 of the Charter of said City of Stamford, the Mayor is hereby requested to cause a report to be made on the contemplated discontinuance of Colahan Street as is more particularly described herein above and shown on Exhibit A.

This resolution was approved on the Consent Agenda at the regular monthly meeting of the 27th Board of Representatives held on Monday, May 4, 2009.

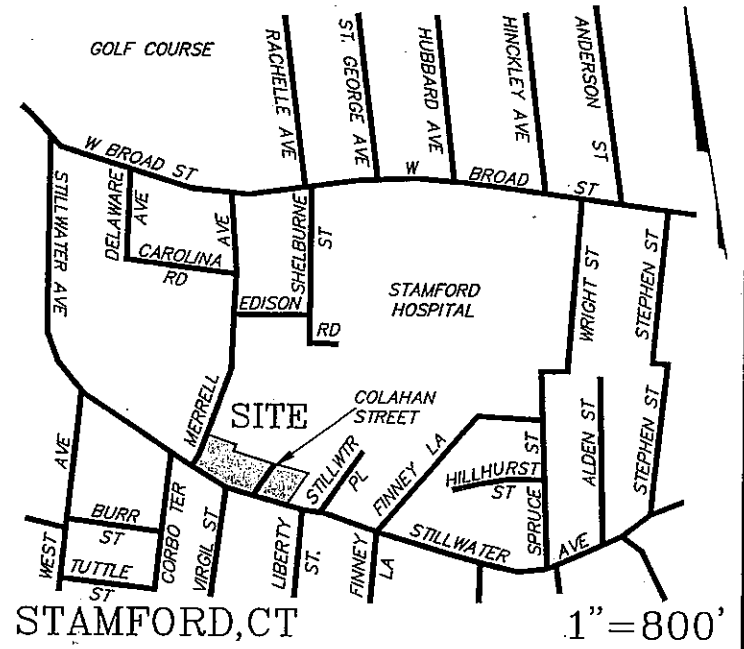
