## RESOLUTION NUMBER 3451 RESOLUTION MEMORIALIZING THE ACCEPTANCE OF BROAD BROOK LANE, CROSS COUNTRY TRAIL, DEER MEADOW LANE, RIVER RIDGE COURT, FOX GLEN DRIVE, WEST ROCK TRAIL AND BUD LANE

**WHEREAS**, Chapter 214 of the Code of Ordinances provides for the acceptance of streets constructed within the City of Stamford as city streets by the Board of Representatives; and

**WHEREAS**, it has been the practice of the Board of Representatives to approve streets via a resolution of the Board and such acceptance is then noted in the land records of the City of Stamford; and

**WHEREAS**, it has been discovered that while the below-listed streets were accepted by the Board of Representatives, such acceptances were not done via resolution; and

**WHEREAS**, it is necessary to memorialize the acceptance of seven streets by resolution in order to ensure that the land records of the City of Stamford accurately reflect the acceptance of these streets as City Streets.

### **NOW THEREFORE BE IT RESOLVED BY THE 28<sup>TH</sup> BOARD OF REPRESENTATIVES THAT:**

The following streets have been accepted as City Streets effective as of the dates noted:

- Broad Brook Lane, effective March 3, 1997;
- Cross Country Trail, effective August 4, 1997;
- Deer Meadow Lane, effective November 5, 1997;
- River Ridge Court, effective March 2, 1998;
- Fox Glen Drive, effective July 6, 1998;
- West Rock Trail, effective January 4, 2000; and
- Bud Lane, effective October 2, 2000.

This resolution shall become effective upon its enactment.


