## RESOLUTION NO. 3334 APPROVING CONNECTIONS TO THE PUBLIC WATER SUPPLY, INCLUDING EXTENSION OF WATER MAINS AND SERVICE LATERALS

**WHEREAS**, the Mayor has received a recommendation from the Director of Health that certain houses located on Alma Rock Road, Mary Joy Lane, a portion of Haviland Road, Sky Meadow Drive (for which there is an existing water main) and a portion of High Ridge Road be promptly connected to the public water supply by the extension of water mains and service laterals, due to elevated levels of dieldrin and chlordane in well water samples collected from houses in the area, which could negatively impact the health and safety of the occupants of the homes whose drinking water is supplied by the wells; and

**WHEREAS**, the Mayor has directed the Office of Operations to prepare an estimate of the cost of connecting the houses in the designated areas to the public water supply; and

**WHEREAS**, the Office of Operations has completed an estimate of the cost of connecting the designated areas to the public water supply by the extension of water mains and service laterals; and

**WHEREAS**, Section 238-21 of the Code of Ordinances of the City of Stamford permits the Board of Representatives to approve (a) the connection of the designated area to the public water supply and extension of the water mains and (b) waiver of reimbursement of all or part of any owner's proportionate share of the cost of said extension; and

**WHEREAS**, the Mayor has requested that the Board of Representatives approve such a connection and waiver of reimbursement; and

**WHEREAS**, the Public Safety and Health Committee of the Board of Representatives has recommended approval of (a) the connection of the houses in the designated area to the public water supply by the extension of the water mains and service laterals, and (b) waiver of all reimbursement by the individual property owners in the designated area of the costs of said extension; and

**WHEREAS**, it is in the best interests of the City to connect the houses in the designated area to the public water supply by extension of the water mains and service laterals and to waive reimbursement by all owners of such houses of the owner's proportionate share of the cost of said extension; and

**NOW THEREFORE BE IT RESOLVED** by the 27<sup>th</sup> Board of Representatives of the City of Stamford that:

(a) the connection of the certain houses located on Alma Rock Road, Mary Joy Lane, Sky Meadow Drive (for which there is an existing water main) and even addresses between 1954 and 2042 on High Ridge Road, to the public water supply by the extension of the water mains and service laterals, as recommended by the Director of Health is approved; and


(b) the connection of the certain houses located on Haviland Road between Scofieldtown Road and Spinning Wheel Lane, and odd addresses between 1991 and 2005 on High Ridge Road that have elevated levels of dieldrin and chlordane in well water samples, to the public water supply by the extension of the water mains and service laterals, as recommended by the Director of Health is approved; and

(c) all reimbursement to the City by the owners of the houses located on Alma Rock Road, Mary Joy Lane, a portion of Haviland Road, Sky Meadow Drive (for which there is an existing water main) and a portion of High Ridge Road, as identified in (a) and (b) above, which are to be so connected to the public water supply by the extension of the water mains and service laterals is waived.


