**RESOLUTION NO. 3307
STILLWATER ROAD
IMPROVEMENTS TO HORIZONTAL AND VERTICAL CURVES**

WHEREAS, The City of Stamford has published a legal notice and a display ad, mailed a letter informing the project meeting to a number of officials and agencies, and mailed a formal letter to abutting property owners and neighborhood residents, announcing a public information meeting on roadway improvements to Stillwater Road horizontal curve realignment in the vicinity of 1045 and 1241-1275 Stillwater Road, and correction to vertical curve in the vicinity of Clover Hill Drive, and repaving of Stillwater Road between 1000 Stillwater Road and Westwood Road, known as Project # 135-295 to enhance safety, and

WHEREAS, a public information meeting was held at 7:00 P.M. on Tuesday, May 19, 2009 in the Stamford Government Center Cafeteria located on the 4th Floor of 888 Washington Boulevard, Stamford, at which citizens had an opportunity to voice their concern, and

WHEREAS, the South Western Regional Planning Agency is IN FAVOR OF INCLUDING THIS PROJECT IN THE transportation Improvement Program and to utilize federal for right of way and construction activities, and

WHEREAS, the funding formula for this project is Federal 80%, State Department of Transportation 10%, and the City of Stamford 10% for each phase of the project including engineering design, rights-of-way, and construction costs, and


