## RESOLUTION NO. 3306 SAFE ROUTES TO SCHOOL PROJECT – K.T. MURPHY SCHOOL

**WHEREAS**, The City of Stamford has published a legal notice and a display ad, mailed a letter informing the project meeting to a number of officials and agencies, and mailed a formal letter to abutting property owners and neighborhood residents, announcing a public information meeting on improvements under the SAFE ROUTES TO SCHOOL PROJECT – K.T. MURPHY SCHOOL, known as Project # 135-298 to enhance safety of school children walking to K.T. Murphy School from the neighborhood, and

**WHEREAS**, a public information meeting was held at 7:00 P.M. on Wednesday, February 25, 2009 in the K.T. Murphy School auditorium located at 9 Horton Street, Stamford, at which citizens and business owners in the project vicinity had an opportunity to voice their concern, and

**WHEREAS**, the South Western Regional Planning Agency is IN FAVOR OF INCLUDING THIS PROJECT IN THE transportation Improvement Program and to utilize federal funds for construction activities, and

**WHEREAS**, the Board of Representatives has considered the concerns of the residents from the public information meeting and finds that the proposed improvements under the SAFE ROUTES TO SCHOOL PROJECT – K.T. MURPHY SCHOOL, Project # 135-298 is in the best interest of the City of Stamford, and will promote the health, safety, and general welfare of its residents and provide for convenience and safety of motoring public.
